1. Due to the prevailing Covid-19 situation in the nation, channel partners have shown reluctance for the trip, hence have requested for encashment as per company policy.
2. Encashment will be 75% of the Trip Cost i.e. (1,40,000 -18% GST) X 75%) = Rs. 88,500/- + GST Extra
3. **Overall Savings as mentioned below (Table A + Table B) : Rs. 2,84,560/- + Rs. 9,80,000/- = Rs. 12,64,560/-**
