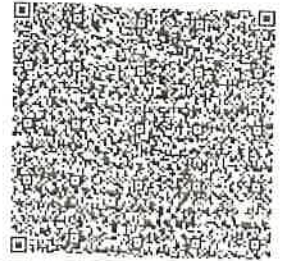

**Subject - Renewal of the License Agreement dated April 22, 2019**
