Subject:- Request for grant of licence for setting up of Group Housing Colony under TOD Zone over an additional area measuring 3.0 acres in addition to License no. 39 of 2013 dated 04.06.2013, 85 of 2014 dated 08.08.2014 and 166 of 2023 dated 18.08.2023) in the revenue estate of village Harsaru, Sector-36A, Gurugram– Krisumi Corporation Pvt. Ltd.

Reference:- Your application dated 16.01.2024 on the subject cited above.

Your application for grant of licence for setting up of Group Housing Colony under TOD Zone over an additional area measuring 3.0 acres in addition to License no. 39 of 2013 dated 04.06.2013, 85 of 2014 dated 08.08.2014 and 166 of 2023 dated 18.08.2023) in the revenue estate of village Harsaru, Sector-36A, Gurugram has been examined and the following deficiencies have been noticed:-

1. Scrutiny fee is deficit by Rs. 5,537/-.
2. You have not submitted certified copy of degree of Architecture and Engineer.
3. You have not submitted Guide map and survey plan of the applied land.
4. Memorandum of undertaking dated 20.01.2024 is unregistered and validity of the same is fixed as one year vide clause no. 1.3. Responsibility to obtain licence is of developer vide clause 2.1, whereas it is of land owner vide clause 9. Hence, contradictory provisions. Pertinently, this MOU is only in principal understanding between the party and final agreement to be executed as is reflected in clause 1 read with clause 12 & 12.2. Hence, the applicant company shall submit revised MOU or collaboration agreement executed with land owning company, which should be registered, irrevocable and responsibility in favour of developer company.
5. You have not submitted copy of GPA/SPA executed with land owning company.

You are requested to remove the above observations and submit the documents within 15 days to enable further action in the matter.
