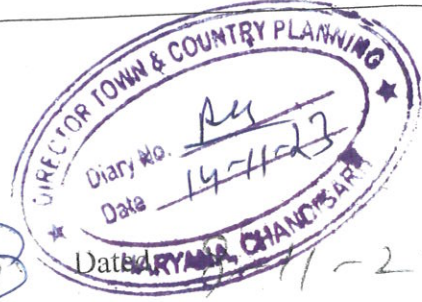

Approval of additional building plans of Phase-3, 4 & 7 and revised building plans of Phase-2 (EWS Block) in Mixed Land Use Colony (97.75% Residential Component & 2.25% Commercial Component) under TOD policy dated 09.02.2016 over an area measuring 30.38125 acres (Licence No. 39 of 2013 dated 04.06.2013 granted for 25.10 acres & Licence No. 85 of 2014 dated 08.08.2014 granted for 2.38125 acres and Licence No. 166 of 2023 dated 18.08.2023 granted for 2.90 acres) in Sector-36-A, Gurugram being developed by Krisumi Corporation Pvt. Ltd.

Reference:- Minutes of meeting dated 08.11.2023 and applicant letter dated 09.11.2023.

On the subject cites above, it is submitted that the report regarding Revised Building Plans of subjected site was sent vide this office memo no. 6797 dated 23.10.2023. The plans were discussed in the BPAC meeting dated 08.11.2023 wherein, it was discussed that "independent entry to the domestic servant unit has not been provided in the building plans. Hence, building plans would require revision.". Now, the applicant company vide representation dated 09.11.2023 has submitted three sets of corrected floor plans (2 nos. drawing). The same have been examined in this office as per HBC-2017 & zoning plan and found in order. Accordingly, three sets of duly signed building plans, are sent herewith.
