## TERMS & CONDITIONS FOR INDUSIND BANK GIFT CARD

- 1) You agree to be bound by these Terms & Conditions by purchasing, activating, using or attempting to use the card or making transaction enquiries or exercising any rights to redeem the value loaded on the card. If you are giving the card to another person, you should ensure that they are aware of the terms and conditions that apply to the card. The user of the card is advised to sign at the appropriate place provided on the reverse side of the card before its use. The card remains the property of IndusInd Bank ("Bank").
- 2) The card is a RuPay Prepaid Card that can be used after activation for purchasing goods and services only in India.
- 3) The card cannot be used to make transactions that exceed the available balance. For such a transaction you will need to pay the difference by another method if the merchant agrees for the same.
- 4) The Card is non-reloadable. It is valid until the expiry date mentioned on the front of the card and cannot be used after expiry. The card cannot be used to obtain or redeem cash and cannot be used for making direct debit, recurring, or regular installment payments.
- 5) IndusInd Bank ("Bank") will send you multiple SMS before card expiry notifying you of the card expiry. Kindly ensure that the contact information is kept up to date.
- 6) The card cannot be used at any ATMs for cash withdrawals or any other activity at the ATM. However, if the card is attempted to be used at an ATM, besides the transaction being declined by the ATM, the cardholder will be charged a fees of ₹ 25/- per attempt. This account will be deducted from the card balance without further notice.
- 7) You shall be responsible for all the transactions on the card. If you notice an error relating to the card, you shall notify us at 18602108887 or email us at reachus@indusind.com
- 8) If you have a problem with a purchase made with the card, or a dispute with the merchant, you must deal directly with the merchant involved. Bank shall not be responsible for any products and/or services availed by you from any of the merchants. If you cannot resolve the dispute with the merchant, you shall notify us at 18602108887 or email us at reachus@indusind.com.
- 9) The Bank reserves the right to place a stop on your card if:
  - a) You report that your card has been lost, stolen or damaged; or
  - b) The bank believes (or reasonably suspects) that the card has been used (or will be used) contrary to these terms and conditions.
- 10) Fuel surcharge inline with the industry standards will be applied on all fuel purchases.
- 11) Card issuance charges of ₹ 100 + GST will be applicable.
